throughout the session, for example before starting a new play activity and before and after eating. Some children may prefer to use hand sanitiser and this will be offered to ensure that hands are cleaned regularly.

Everyone is encouraged to avoid touching face, eyes, nose or mouth with unclean hands.

We will remind everyone to cover their mouth and nose with a disposable tissue (not their hands) when they cough or sneeze and throw the tissue straight away in the nearest bin. Tissues will be available both inside and outside and a bin will be within 2 metres of the tissues. These are lidded bins and the surface will be cleaned regularly. After using a tissue hands will be washed for 20 seconds or hand sanitizer will be used.

Staff teams will ensure good respiratory hygiene by promoting the 'catch it, bin it, kill it' approach.

We will provide learning opportunities for children to learn and practise good hygiene through games, songs and repetition and puppet shows. entering the building.

Rigorous checks carried out by line managers to ensure that the necessary procedures are being followed.
